

HEALTH & ADVOCACY



A JOURNEY OF TRANSFORMATION

Drunk and livid with rage, Suresh, a 35-year-old alcoholic, staggered along the streets of Mumbai, hreatening to kill passers-by with his knife. Hysterically sobbing and fearing for her life, his wife Anjali along with a few concerned neighbours, turned to the police who arrested Suresh. They kept him in custody for a week during which he sobered up cold-turkey. However, this was short-lived as he relapsed after a few days and began physically abusing his wife. This, along with accusations of an affair, broke Anjali and deeply affected her emotional health. Distressed and at the end of the line, she asked the health educator who visited her weekly for advice on what to do regarding her husband's alcoholism. Alcoholism is a common but serious issue in Suresh's locality but through ACT and its local partner, intervention took place and Suresh was directed to the nearest Alcoholics Anonymous centre. Initially, Suresh adamantly refused to attend meetings saying he did not need any help, but finally accepted the support of the group and started attending meetings. Much to his surprise, he began to enjoy them and became a regular, quitting alcohol soon after. Suresh even started to write a book documenting his struggles with alcohol and addiction. It has been six months since Suresh last had a drop of alcohol and his life has dramatically changed for the better. He now has a steady job and enough money to take care of his household. His son, who would earlier hide rom him, now runs into his arms. They are grateful for all that ACT and its local partner have done-Suresh for being freed from his addiction, and his wife for now having the husband of her dreams.

MENTAL HEALTH

There are three facets of our program involved in mental health:

- Training lay-counselors to provide basic counseling to the vulnerable population within the community. The beneficiaries vary from boys struggling with an adolescent crush to women facing domestic abuse and violence.
- Working in partnership with rescue and rehabilitation organizations to provide the psycho-social components of the rehabilitation process of victims of trafficking and sexual abuse. We also provide different forms of therapy by trained counselors- our wish is to see the girls reintegrated into society.
- We train mental health workers to increase awareness on common and severe mental health disorders to various communities so that there is identification and treatment of such cases. As a result of this awareness, stigma and discrimination is significantly reduced.

The Mediator Role of ACT

Beauty in diversity is what is evident when the youth meeting at Kishan Nagar takes place today.

But just last year it was a different scenario, when the sparse attendance at these meetings was extremely disheartening for the local leaders.

ACT intervened and conducted a survey of the locality while trying to understand why the youth were disinterested in attending these meetings. While conducting the survey, the ACT staff met with community and youth leaders to discuss and understand the problems they were facing when it came to engaging with the community.

The survey findings stated that the leadership in the community were oblivious to the issues faced by the youth. This resulted in community elders changing their directive approach to a more facilitative form of communication.

It has been a joy to watch the increased attendance not only at the meetings but in all the activities of the community. More and more young people now have a voice and say in their community.



YOUTH LEADERSHIP SKILLS

This program has been an eye-opener to many young boys and girls in understanding their self-worth. We conduct this program in schools, communities and shelter homes and have seen how instrumental it has been in influencing the young people to make right choices.

ACT is primarily a training and capacity-development organization for communities, churches and other partner NGOs. We have developed a curriculum for counselling – both basic and advanced levels. We have also developed a database of Christian NGOs and churches in the city.

LIFE SKILLS



SCHOOL COUNSELLING

Sunny is a 11 year old boy studying in one of the schools in South Mumbai. He was first referred to the counsellor by the Principal when he was in the 5th grade.

He had stolen a classmate's birthday chocolates furtively while the other students were still in the library. He would also indulge in emotional outbursts at various times like throwing things belonging to others in the dustbin.

Hence he was found to be repeatedly aggressive and difficult to manage in school. When referred he was already on medication for ADHD. Our counsellor found the child to be fidgety, blaming others, smiling inappropriately. When she asked him the reasoning behind taking the chocolates without permission he casually mentioned that he just felt like eating them. He seemed to lack impulse control.

Our Counsellor spent time building rapport and understanding Sunny who felt that he was being targeted both by the teachers and by his peers. He used to tell the counsellor that if anyone torments him he would fight back. Our Counsellor began training him in anger management techniques. She also used various stories to help the child understand the consequences.

On his promotion to the 6th grade he continued to be defiant and stubborn. After many sessions of discussions with the counsellor he began to comprehend that his response was inappropriate. This realisation made him apologize to the concerned teachers. These are huge strides of progress that we have begun to perceive in Sunny's emotional health. He is now in the 7th grade and both his parents and teachers are delighted at his progress.

TRAUMA COUNSELLING

Meena, now thirty-five years old has had a life full of hardship and distress. A hopeful job search brought her to Mumbai but ended abruptly when she was sold into the sex trade after being betrayed at the hands of a friend from her village.

Meena was rescued and taken in by an organisation where she was given a home and provided for. Full of pent-up emotions with not a soul to share with, she ran away and returned to the only place she knew as home- the brothel.

She was rescued again but this time by another organisation She was taken to their training centre where she was taught how to stitch bags as a vocation to enableher to earn a livelihood.


With her determination and drive to live a better life, she became highly skilled at this task. With nothing but five years of trauma to her name, Meena received counselling from ACT to cope with life outside of her past. Her self-esteem had hit rock bottom and her anger had reached a deafening crescendo, but through the multiple counselling sessions with the ACT counsellor, Meena has been able to overcome these issues and now has a healthy relationship not only with her husband and family, but also with herself. The trauma counselling intervention has helped her to adjust to life outside of the brothel.

Meena is now employed at a factory in the suburbs which is a safe zone for rescued women. She is now a full time employee and lives a life of dignity and pride.

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF ASSOCIATION FOR CHRISTIAN THOUGHTFULNESS

Opinion

We have audited the accompanying financial statements of **ASSOCIATION FOR CHRISTIAN THOUGHTFULNESS** (the Society), which comprise the Balance Sheet as at 31st March, 2019, the Statement of Income and Expenditure for the year then ended and notes to the financial statements, including summary of the significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Society as at 31st March, 2019 and of its financial performance for the year then ended in accordance with the Accounting Standards issued by the Institute of Chartered Accountants of India (ICAI).

Basis for Opinion

This responsibility includes the design, implementation and maintenance of internal control relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Society's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Society or to cease operations, or has no realistic alternative but to go so?

Those charged with governance are responsible for overseeing the Society's financial reporting process.
